THE DANUBE TRANSNATIONAL PROGRAMME (DTP) OVERVIEW

DTP is a financing instrument of the European Territorial Cooperation (ETC), better known as Interreg. ETC is one of the goals of the European Union cohesion policy and provides a framework for the implementation of joint actions and policy exchanges between national, regional and local actors from different Member States. The programme promotes economic, social and territorial cohesion in the Danube Region through policy integration in selected fields.

The DTP four main thematic priorities are:

1. Innovative and socially responsible Danube region
2. Environment and culture responsible Danube region
3. Better connected and energy responsible Danube region
4. Well – governed Danube region



The programme area covers nine Member States (Austria, Bulgaria, Croatia, Czech Republic, Hungary, Germany – Baden-Württemberg and Bayern, Romania, Slovakia and Slovenia) and five non-EU Member States (Bosnia and Herzegovina, Moldova, Montenegro, Serbia and four provinces of Ukraine), being composed of 69 NUTS-2 regions.

The Rozmberk Society is the project partner from the Czech Republic. Together with local partners, the Society will establish a new WWI monument and develop education materials, trails, and exhibitions on WWI heritage.

WALK OF PEACE

Based on the cultural-architectural heritage of the First World War along the former Southwestern Front between the Austro-Hungarian Monarchy and the Kingdom of Italy, the idea of the "Walk of Peace" has been initiated in the 1970s by the Austrian Dolomitenfreunde Association. It has been developed further by the Slovenian Foundation Walk of Peace and Italian associations along the former Isonzo Front, which formed a part of the Southwestern Front of WWI.

Within the NETWORKLED project activities, the Walk of Peace brand will be extended throughout the Danube region as a common brand of the heritage of the First World War.

The brand contributes to the commemoration of all casualties of WWI and promotes the values of peace and respect. It also contributes to raising awareness of the WWI heritage and promoting sustainable tourism development.

Since 2016, the "The Walk of Peace from the Alps to the Adriatic – Heritage of the First World War" in Slovenia has been included in the UNESCO Tentative List.

The Rozmberk Society will include the brand where possible in new and existing trails in the Czech Republic.
